**ASSIGNED COMMISSIONER'S RULING  
INVITING APPLICATIONS FOR APPOINTMENT TO  
THE LOW INCOME OVERSIGHT BOARD**

Public Utilities Code<sup>1</sup> § 382.1 establishes a Low-Income Oversight Board (LIOB) to advise the California Public Utilities Commission (Commission) on low-income electric, gas, and water customer issues. The LIOB serves as a liaison for the Commission to low-income ratepayers and representatives. Due to unforeseen circumstances, a public position on the LIOB became available in September 2010. On September 28, 2010, I issued a ruling inviting individuals interested in applying for this position to submit a letter of interest, a résumé, and three letters of reference. As of the deadline, the Commission received one application. By this

ruling, I am reopening the application process through November 22, 2010 in order to receive a larger pool of applicants.

The LIOB is comprised of 11 members. The open position is held by one of five members selected by the Commission who have expertise in the low-income community and who are not affiliated with any state agency or utility. This position is for a two-year term from the date of appointment by the Commission.

As set forth in § 382.1, the responsibilities of the LIOB are to:

1. Monitor and evaluate implementation of all programs provided to low-income electricity, gas, and water customers.
2. Assist in the development and analysis of any assessments of low-income customer need.
3. Encourage collaboration between state and utility programs for low-income electricity and gas customers to maximize the leverage of state and federal energy efficiency funds to both lower the bills and increase the comfort of low-income customers.
4. Provide reports to the Legislature, as requested, summarizing the assessment of needs, audits, and analysis of program implementation.
5. Assist in streamlining the application and enrollment process of programs for low-income electricity and natural gas customers with general low-income programs, including, but not limited to, the Universal Lifeline Telephone Service program and, including compliance with § 739.1.
6. Encourage the usage of the network of community service providers in accordance with § 381.5.

The LIOB holds 4 to 5 meetings annually with additional meetings and/or conference calls as necessary. The LIOB alternates meeting locations between northern, central and southern California. Members of the LIOB are eligible for compensation in accordance with the state's travel guidelines.

Upon receipt and review of the applications, we will select candidates to be interviewed the last week in November. The application process for the final applicant will include a review of economic interests. We encourage applicants to refer to <http://www.fppc.ca.gov/forms/700-07-08/Form700-07-08.pdf> prior to submitting a letter of interest, to determine if potential conflicts of interest may exist. The nominee must be approved by the full Commission.
