**ADMINISTRATIVE LAW JUDGE'S RULING  
SHORTENING THE TIME TO RESPOND TO PETITION  
TO MODIFY DECISION 06-12-038**

On April 10, 2007, Pacific Gas and Electric Company and San Diego Gas and Electric Company (Joint Utilities) filed a Joint Petition to Modify Decision (D.) 06-12-038 requesting permission to extend their current Low Income Energy Efficiency (LIEE) prime contractors' contracts for a year until the end of 2008. The Joint Petition also seeks a delay to competitively hire new LIEE prime contractors or program implementation contractors until the next LIEE program cycle commencing in 2009.

Together with the petition, the Joint Utilities filed a motion for expedited treatment of their petition. The Joint Utilities argue that expedited treatment is

necessary because otherwise, the resulting decision from the petition would be issued too late for the utilities to complete the competitive bidding process and ensure that new contractors are ready to implement the program at the beginning of 2008.

Without reviewing the responses, I am hesitant to direct expedited treatment of the petition at this time. However, without addressing the merits of the petition, good cause exists to expedite the responses thereto. Responses to the Joint Utilities' April 10, 2007 Petition to Modify D.06-12-038 shall be filed by Wednesday, April 18, 2007, and replies to the responses shall be filed by Friday, April 20, 2007.

**IT IS RULED that:**

1. The Joint Utilities' April 10, 2007 Motion for Expedited Treatment of the Joint Petition to Modify Decision (D.) 06-12-038 is granted to the extent set forth below.

2. Responses to the Joint Utilities' April 10, 2007 Petition to Modify D.06-12-038 shall be filed by Wednesday, April 18, 2007, and replies to the responses shall be filed by Friday, April 20, 2007.
