**INTRODUCTION**

Pursuant to Ordering Paragraph 6 of Decision ("D.") 07-12-051, dated December 20, 2007, Bear Valley Electric Service ("BVES") hereby submits its Affidavit of compliance with Assembly Bill ("AB") 2104. As directed by D.07-12-051, the attached Affidavit of Keith Switzer, Vice President-Regulatory Affairs, describes BVES' processes for complying with the following elements of AB 2104:


(A) Developing processes whereby electrical corporations and gas corporations are able to directly accept CARE applications from tenants of a mobile home park, apartment building, or similar residential complex;

(B) Developing processes whereby electrical corporations and gas corporations are able to directly notify and provide renewal applications to tenants of a mobile home park, apartment building, or similar residential complex, that are existing CARE customers;  
and

(C) Developing processes whereby each electrical corporation and gas corporation is required to provide each master-meter customer that is subject to Section 739.5 with a list of tenants who are approved to receive discounts pursuant to the CARE program. The list

shall specifically identify those tenants added to or deleted from CARE program eligibility since the previous billing cycle.

CERTIFYING  
COMPLIANCE WITH ASSEMBLY BILL 2104**

**A. Has developed processes whereby it directly accepts CARE applications from tenants of a mobile home park, apartment building, or similarly residential complex.**

BVES accepts CARE applications from all sub-metered tenants.

**B. Has developed processes whereby it directly notifies and provides renewal applications to tenants of a mobile home park, apartment building, or similar residential complex that are existing CARE customers.**

BVES is still developing a process whereby it can directly notify and provide renewal applications to sub-metered customers. BVES anticipates having a system in place by the summer of 2008.

**C. Provides each master-meter customer that is subject to Section 739.5 with a list of tenants who are approved to receive discounts pursuant to the CARE program and that specifically identifies those tenants added to or deleted from CARE program eligibility since the previous billing cycle.**

BVES monthly billing statements to its master-metered customers includes a list of all active CARE participants for the current billing cycle. This list also includes those tenants who have been enrolled and removed from the program since the last billing.


