**AFFIDAVIT OF SIERRA PACIFIC POWER COMPANY (U 903-E) CERTIFYING  
COMPLIANCE WITH ASSEMBLY BILL 2104**

- A. Has developed processes whereby it directly accepts CARE applications from tenants of a mobile home park, apartment building, or similarly residential complex.**

Sierra has a full service contract with the Department of Community Services and Development (CSD) to perform all functions related to the eligibility and re-certification requirements of CARE applicants. Sierra has a process in place in which sub-metered tenants may apply for CARE directly to CSD by providing CSD with a copy of their bill given to them by the mobile home park, apartment building or other residential complex, a completed application, along with their income verification. If the applicant is CARE eligible, CSD places them on Sierra's weekly report and mails the applicant a letter telling them they are CARE eligible and instructing them to give their park manager or coordinator a copy of their letter so that they receive the CARE discount. Alternatively, Sierra also accepts CARE self-certification applications directly from sub-metered tenants.

- B. Has developed processes whereby it directly notifies and provides renewal applications to tenants of a mobile home park, apartment building, or similar residential complex that are existing CARE customers.**

Sierra has arranged for CSD to provide renewal CARE applications directly to sub-metered tenants.


- C. Provides each master-meter customer that is subject to Section 739.5 with a list of tenants who are approved to receive discounts pursuant to the CARE program and that specifically identifies those tenants added to or deleted from CARE program eligibility since the previous billing cycle.**

Sierra's monthly billing statements to its master-metered customers list the tenant unit numbers receiving the CARE discount. In addition, a letter is enclosed with each billing monthly statement detailing those units that are qualified to receive the CARE discount and those that no longer receive the CARE discount since the previous billing cycle. The detailed information in the letter includes the tenant's name, unit number and CARE qualification or cancellation date.
