## ORDER CLOSING PROCEEDING

#### 1. Summary

By this order, we hereby close the above-captioned consolidated proceeding (Proceeding), which relates to the 2009-2011 Budget Applications for Low Income Energy Efficiency (now referred to as Energy Savings Assistance (ESA) Program) and California Alternate Rates for Energy of Pacific Gas and Electric Company, Southern California Edison Company, San Diego Gas & Electric Company, and Southern California Gas Company.

On January 20, 2010, an updated Joint Scoping Memo and Ruling (2010 Scoping Ruling) was issued in the Proceeding setting forth the Proceeding schedule which anticipated leaving the Proceeding open until December 31, 2011 and extended the statutory deadline by ordering it to remain open beyond the 18-month period as specified in Public Utilities Code Section 1701.5.

This extension was ordered to allow for adequate time to address several outstanding issues in the Proceeding, which included a resolution of a pending

petition to modify Decision (D.) 08-11-031 as well as oversight activities relating to several ongoing pilot programs and studies (e.g. 2009 Impact Evaluation; the 2010 Process Evaluation; the Non-Energy Benefits Study; the High Usage Needs Assessment; the Refrigerator Degradation Study; the CARE Recertification Study; etc.). Most importantly, the Commission's and Administrative Law Judge's (ALJ) ongoing direction regarding policy and protocols for these activities were anticipated to continue through the end of 2011.

On December 15, 2011, the Commission issued D.11-12-049 approving a 60-day extension until February 29, 2012 to allow for final resolution of several outstanding cycle-end issues.

All the pending matters that were identified in the 2010 Scoping Ruling, including all cycle-ending fund shifting have now been concluded, and no further issues are anticipated to be addressed as part of this docket.

#### 2. Comments on Proposed Decision

The proposed decision of ALJ Kim in this matter was mailed to the parties in accordance with Section 311 of the Public Utilities Code and comments were allowed under Rule 14.3 of the Commission's Rules of Practice and Procedure.
