

Southern California Edison Company (SCE) on behalf of itself, Southern California Gas Company, San Diego Gas & Electric Company, and Pacific Gas and Electric Company (the "Utilities") submitted annual estimates of CARE eligible customers and related information on enrollment benchmarks to be achieved in 2005 to the Commission on October 15, 2004. Minor enhancements have been made to the geographic assignment of customers that are near county lines based on available census and vendor data. Therefore, the utilities are resubmitting the Tables from Attachment A in the October 15, 2004 filing to reflect the impact of those enhancements. While these adjustments affect a very small fraction of overall customers, they do slightly change the demographic eligibility rates that were included in the October 15<sup>th</sup> filing. Since these demographic eligibility rates will be used by the utilities throughout 2005 for monitoring the estimated eligible population, the utilities believe it is appropriate to update them in this filing. The change in the overall estimates of eligible customers for the utilities is so small, as

indicated in the revised tables for Attachment A, that the utilities are not proposing to change the enrollment benchmarks that were submitted in Attachment B.
