**APPLICATION OF SOUTHERN CALIFORNIA EDISON COMPANY (U 338-E) FOR

**I.**

**INTRODUCTION**

In accordance with the California Public Utilities Commission's (Commission) directives as set forth in Decision (D.) 07-12-051<sup>1</sup> in Rulemaking (R.) 07-01-042 and the guidance provided in the Assigned Commissioner's Ruling (ACR) of April 1, 2008,<sup>2</sup> Southern California Edison Company (SCE) hereby files this Application for Approval of Low-Income Assistance Programs and Budgets for Program Years 2009, 2010 and 2011 (the "Application").

The concurrently-served supporting testimony (the “Testimony”),<sup>3</sup> set forth in what has been preliminarily marked for identification as Exhibit SCE-1, is divided into chapters and discusses SCE's proposed administrative activities and budgets for 2009, 2010 and 2011 by expenditure category, as well as details concerning SCE's low-income assistance program plans. Details of the Low-Income Energy Efficiency (LIEE) program are discussed in Chapter 1, the California Alternate Rates for Energy (CARE) program in Chapter 2, and the Cool Center program in Chapter 3. The supporting Testimony also describes SCE's proposed ratemaking treatment.

## II.

### **ORGANIZATION OF SCE'S TESTIMONY**

#### **A. Chapter 1 – The LIEE Program**

The Testimony served in support of the LIEE program consists of nine sections in accordance with the guidance provided in the ACR.

Section I provides an overview and discusses the context and background for this filing, along with a short summary of SCE's requests. John Nall is sponsoring the Testimony for this section.

Section II sets forth the background of the LIEE program, including a brief history of the program and how it has evolved since its inception, the impact of the program on the low-income customers it serves, and how the program is funded. John Nall is sponsoring the testimony for this section.

Section III outlines SCE's proposed LIEE program goals for 2009, 2010 and 2011, describing how the program (a) achieves ¼<sup>th</sup> of the Commission's Programmatic Initiative; (b)

meets policy objectives; (c) sets forth program goals by population/segments; and (d) meets savings goals. John Nall is sponsoring the Testimony for this section.

Section IV describes the cost-effectiveness and energy savings of SCE's proposed program. Marian Brown is sponsoring the Testimony for this section.

Section V details SCE's program design for the 2009-2011 budget cycle, and includes a brief overview of the program design and the mechanics of the program delivery with attention to the increased efforts towards greater cooperation among SCE, Southern California Gas Company (SoCalGas), Pacific Gas and Electric Company (PG&E), and San Diego Gas & Electric Company (SDG&E) (collectively, the "Joint Utilities"). This section also discusses the program's portfolio composition and addresses Assembly Bill 1109 and the proposed modification to the Ten-Year "Go-Back" Rule. John Nall and Marian Brown are sponsoring the Testimony for this section.

Section VI sets forth a detailed description of SCE's proposed 2009-2011 LIEE budget, a method for reporting costs and discusses methods to promote program continuity and long-term LIEE investments with more flexible budgeting and funding rules. John Nall is sponsoring the testimony for this section.

Section VII discusses SCE's proposed ratemaking treatment for SCE's LIEE programs. Jill Holmes is sponsoring the Testimony for this section.

Section VIII explains that SCE is not required to competitively bid the administration of its LIEE programs. John Nall is sponsoring the Testimony for this section.

Section IX summarizes and concludes SCE's requests for its 2009, 2010 and 2011 LIEE program. John Nall is sponsoring the Testimony for this section.

## **B. Chapter 2 – The CARE Program**

The Testimony served in support of the CARE program consists of eight sections in accordance with the Commission's guidance document issued in connection with the ACR.

Section I is introductory in nature and provides a high level summary of SCE's requests for its CARE program for the 2009, 2010 and 2011 program years. John Nall is sponsoring the Testimony for this section.

Section II outlines the background of the CARE program, its purpose, and the new opportunities created to jointly market the CARE and LIEE programs when the Commission aligned the programs income guidelines.<sup>4</sup> John Nall is sponsoring the Testimony for this section.

Section III sets forth a detailed budget of SCE's proposed program activities and administrative costs, which have been specifically designed to support the Commission's goal of enrolling all CARE-eligible customers who wish to participate in the program. John Nall is sponsoring the Testimony for this section.

Section IV describes the administration of SCE's CARE program, the changes and improvements that are proposed for the program by category, and includes the cost by category. John Nall and Marian Brown are sponsoring the Testimony for this section.

Section V includes a discussion of the program's current outreach efforts, ways to improve upon these efforts and the estimated costs associated with these improvements. Particular attention is given to the nexus between outreach efforts and meeting participation goals in specific population sectors or sections, including those CARE-eligible customers residing in Section 8 Housing and Public Housing. John Nall is sponsoring the Testimony for this section.

Section VI discusses SCE's proposed ratemaking treatment for the CARE program. John Nall and Jill Holmes are sponsoring the Testimony for this section.

Section VII includes SCE's request to both continue funding for the CARE program and to allow for flexibility in managing the funds for the program in each year of the 2009-2011 funding cycle. John Nall is sponsoring the Testimony for this section.

Section IV discusses SCE's proposed Cool Center program measurement and evaluation to be undertaken in 2009. Marian Brown is sponsoring the Testimony of this section.

Section V discusses SCE's proposed ratemaking treatment for the Cool Center program. Jill Holmes is sponsoring the Testimony for this section.

Section VI includes SCE's request to both continue funding for the Cool Center program and to allow for flexibility in managing the funds for the program in each year of the 2009-2011 funding cycle. John Nall is sponsoring the Testimony for this section.

Section VII summarizes and concludes SCE's request for commission approval of its Cool Center program plans and budgets for the 2009-2011 cycle. John Nall is sponsoring the testimony for this section.

### III.

#### **SUMMARY OF SCE'S REQUEST**

In this Application, SCE requests the Commission's approval of SCE's proposals, which will allow SCE to continue to effectively and efficiently administer critical low-income assistance programs, namely the LIEE, CARE and Cool Center programs.

First, SCE seeks approval of its LIEE program plans and proposed budget. The Commission, through D. 07-12-051, R. 07-01-042 and D. 07-10-032, has broadened the scope of the low-income assistance programs and authorized a three-year budget cycle that will allow SCE and the Joint Utilities to adequately address the Commission's new direction, particularly in meeting the Commission's immediate goal of achieving ¼<sup>th</sup> of the Programmatic Initiative by 2011. Adoption of SCE's proposed LIEE program plans will further the Commission's goal of making the LIEE programs a cost-effective energy resource and providing energy efficiency measures to every willing and eligible low-income household by the year 2020. Additionally, SCE's proposals (a) help provide health, comfort, and safety to its low-income customers; (b) reduce energy bills; and (c) lessen any detrimental impact on the environment.

Second, SCE seeks approval of its CARE program plans and proposed budget, adoption of which will further the Commission's goal of enrolling all eligible customers in CARE who are willing to participate.

Third, SCE seeks approval of its Cool Center program plans and proposed budget, adoption of which will further the Commission's objective of providing assistance to low-income, senior and disabled residents living in isolated, extreme climate areas during the hot summer months.

Finally, SCE seeks approval of its proposed ratemaking treatment for the LIEE, CARE and Cool Center programs.

SCE's proposed LIEE budget exceeds its current budget collected through rates. SCE's proposed CARE program budget exceeds the level as approved for 2007 and 2008. The adoption of a 2009, 2010 and 2011 Cool Center program will also increase the low-income assistance

program total costs. As a result of the Commission’s adoption of its Programmatic Initiative, SCE’s proposed plans and budgets have been expanded. Compared to revenues at present rates of \$11,542,624 million, SCE is requesting a revenue increase of approximately \$24.2 million or 0.2 percent on an annualized basis for the years 2009, 2010 and 2011. The percentage of increase in total revenue is less than 1%. The following table shows an estimate of proposed revenues and rate changes by customer group.

**A. Approval of SCE’s LIEE Administrative Costs and Budget**

In its supporting Testimony, SCE has set forth detailed descriptions of its proposed LIEE administrative activities and program design plans for program years 2009, 2010 and 2011, along with the estimated three-year budget. In D.06-12-038, as modified by D.07-06-004, SCE was authorized to spend approximately \$3.2 million on its 2007 and 2008 LIEE program, including administration costs. SCE proposes a three year LIEE budget of \$165 million for 2009-2011. SCE’s proposed budget reflects SCE’s ongoing effort to constantly improve its LIEE (or “Energy Management Assistance” (EMA)) program to better serve the needs of its low-income customers. Additionally, the portfolio is augmented by measures that will produce long-term and enduring savings, such as cooling measures that help promote the comfort, health and safety of eligible low-income customers. SCE’s proposed LIEE program is designed to achieve 1/4<sup>th</sup> of the Programmatic Initiative by December 2011. In summary, SCE has presented detailed descriptions of its proposed LIEE plans and expenditures, which SCE contends are reasonable. As such, SCE respectfully requests approval of its proposed plans and three-year budget of \$165 million for the 2009-2011 timeframe.



**B. Approval of SCE's CARE Administrative Costs and Budget**

In its supporting Testimony, SCE has set forth detailed descriptions of its proposed CARE administrative activities planned for 2009, 2010 and 2011 by expenditure category, along with the estimated budget allocation of each category. SCE is authorized to spend up to \$4.2 million on CARE administration during 2007 and 2008, which includes outreach, program support, information technology, and other administrative activities. SCE proposes an increased budget amount of \$5,541,000 in 2009, \$5,412,000 in 2010 and \$5,485,000 in 2011. As CARE enrollment and penetration rates increase, the remaining CARE-eligible customers will become increasingly difficult to reach. Sophisticated outreach will be required to enroll new CARE customers from a shrinking pool of remaining eligible customers who have not enrolled in the program. SCE's 2009-2011 CARE programs are designed to continue progression toward the Commission's goal of enrolling all eligible customers who are willing to participate in CARE and maintain those customers on the CARE rate through the recertification process. In summary, SCE respectfully requests approval of its proposed CARE budgets.

**C. Approval of SCE's Cool Center Program Administrative Costs and Budget.**

In the supporting Testimony, SCE has set forth a detailed description of the proposed Cool Center program activities planned for program years 2009, 2010 and 2011, by category, along with the estimated budget for each category. SCE proposes to spend up to \$777,000 in 2009, \$742,000 in 2010 and \$792,000 in 2011 on Cool Center Program administration for the three-year budget cycle, which includes funding approximately 20 Cool Centers in the target communities, outreach, program support, information technology, program activities, measurement and evaluation, and other administrative activities. SCE contends that the proposed plans and budgets are reasonable, and thus respectfully requests that the Commission adopt SCE's proposed Cool Center program and budgets.

**D. Adoption of SCE's Ratemaking Proposal.**

SCE proposes no changes to the currently-approved LIEE ratemaking. SCE's current ratemaking associated with LIEE includes: (1) the recovery of the Commission-authorized LIEE revenue requirement through the operation of the Public Purpose Programs Adjustment Mechanism (PPPAM); and (2) the comparison of the authorized LIEE revenue requirements with actually incurred LIEE expenses in the Low-Income Energy Efficiency Programs Adjustment Mechanism (LIEEPAM).

As discussed in the supporting Testimony, SCE proposes to modify the currently approved CARE ratemaking treatment. SCE proposes to include the annual Family Electric Rate Assistance (FERA) program-related administrative funding in the authorized CARE revenue requirement, transfer the recorded December 31, 2008 Family Energy Rate Assistance Balancing Account (FERABA) balance to the PPPAM balancing account, and eliminate Preliminary Statement, Part Z, FERABA.

Consistent with SCE's approved 2007-2008 Cool Center ratemaking treatment, SCE seeks to continue to record the 2009-2011 Cool Center program expenses to the PPPAM by modifying Preliminary Statement, Part FF, PPPAM, to record up to \$777,000 in 2009, \$742,000 in 2010 and \$792,000 in 2011 in incremental Cool Center program costs, associated with implementing the 2009-2011 Cool Center programs.

SCE respectfully requests the adoption of its ratemaking proposals for CARE, LIEE, and Cool Center programs.

## IV.

### **STATUTORY AND PROCEDURAL REQUIREMENTS**

#### **A. Statutory and Procedural Authority**

This Application is made pursuant to D.07-12-051 in R.07-01-042, the Commission's Rules of Practice and Procedure, the California Public Utilities Code, and the reporting requirements for low-income assistance programs.

SCE's authority for this request includes, but is not limited to, Sections 382, 399.2, 399.9, 451, 491, 701, 702, 739.1, 739.2, and 739.4 of the California Public Utilities Code, and prior decisions, orders and resolutions of this Commission.

SCE's request complies with Rules 1.5 through 1.11 and 1.13, which specify the procedures for the filing of documents.<sup>5</sup> In addition, this request complies with Rules 2.1., 2.2 and 3.2.

#### **B. Rule 2.1(c)**

Rule 2.1(c) requires that applications shall state "[t]he proposed category for the proceeding, the need for hearing, the issues to be considered, and a proposed schedule." These requirements are discussed below.

##### **1. Proposed Categorization**

SCE proposes to characterize this proceeding as "ratesetting" as defined in Rule 1.3(e).

##### **2. Need for Hearing and Proposed Schedule for Resolution of Issues**

SCE's proposals submitted herein and set forth in the supporting Testimony constitute a sufficient record for the Commission to rule on SCE's low-income assistance

program plans and budgets without the need for evidentiary hearings. SCE believes that all interested parties can comment and express their views through written protests and comments.

Accordingly, SCE proposes the following schedule:

If hearings are deemed necessary, however, SCE requests that such proceedings be expedited and the schedule be designed and maintained so that a final decision will be rendered before the end of 2008 so as to avoid any substantial delays in program rollout in 2009. As a result of the Commission's expansion of the LIEE programs, SCE will need sufficient time within which to implement these changes before the initiation of the 2009 program year. To the extent that there are major modifications to the low-income assistance programs as a result of this proceeding, it may take additional time to implement such changes, further delaying actual program delivery to SCE's low-income customers.

**CONCLUSION**

On the basis of the above-stated reasons, SCE respectfully requests that the Commission issue an order:

- Approving the 2009, 2010 and 2011 Low-Income Energy Efficiency program plans and budgets as set forth above;
- Approving the 2009, 2010 and 2011 California Alternate Rates for Energy program plans and budgets as set forth above;
- Approving the 2009, 2010 and 2011 Cool Center program plans and budgets as set forth above;
- Approving the proposed ratemaking treatment to cover the anticipated costs of the low-income assistance programs plans and budgets;
- Approving removal of fund-shifting restrictions imposed in D.06-12-038, and approval to reallocate funding among LIEE budget categories as changed conditions warrant to meet the Commission's LIEE Programmatic Initiative;
- Approving authorization to continue leveraging resources in providing gas-related measures and weatherization services to customers receiving gas service from SCE on Catalina Island, as described in the Testimony;
- Approving development of a statewide LIEE program name instead of a statewide tagline and approval of the program name, which will be submitted to the Commission by July 14, 2008, as described in the Testimony;



- Approving revisions to the Statewide Policies and Procedures Manual and Weatherization Installation Standards Manual to reflect the addition of new measures after receiving appropriate public input;
- Approving proposed carry-over funding guidelines for measurement and evaluation, as described in the Testimony;
- Approving funds committed through the California New Homes Program to be reserved, as necessary, into the next program cycle beginning in 2012, as described in the Testimony;
- Approving reallocation of funding among CARE budget categories as changed conditions warrant to meet CARE goals and objectives;
- Approving funding of LIEE activities in 2009 using proposed 2009 program funds in the event of Commission delay in issuing a decision on SCE's 2009-2011 low-income program budgets;
- Approving the new CARE processes described in the Testimony;
- Approving inclusion of the annual FERA-related administrative funding in the authorized CARE revenue requirement, and transference of the recorded December 31, 2008 FERABA balance to the PPPAM balancing account, and eliminating Preliminary Statement, Part Z, FERABA;
- Approving funding of CARE activities in 2009 using proposed 2009 program funds in the event of Commission delay in issuing a decision on SCE's 2009-2011 low-income program budgets;
- Approving reallocation of funding among Cool Center budget categories as changed conditions warrant to meet Cool Center goals and objectives;
- Approving funding of Cool Center activities in 2009 using proposed 2009 program funds in the event of Commission delay in issuing a decision on SCE's 2009-2011 low-income program budgets; and

- Granting such other relief as the Commission finds just and reasonable.
