1. Join the meeting at

2. Connect to audio

- Use computer for audio [PREFERRED] —Use your computer with a headset or speakers, OR

Call in—Dial in from your phone when the meeting starts:

Note: If using your phone for audio, please **first** join the Webex from your computer, then call in and enter the Attendee ID the system assigns you. The host may not be able to mute and unmute call-in users that do not follow this protocol.

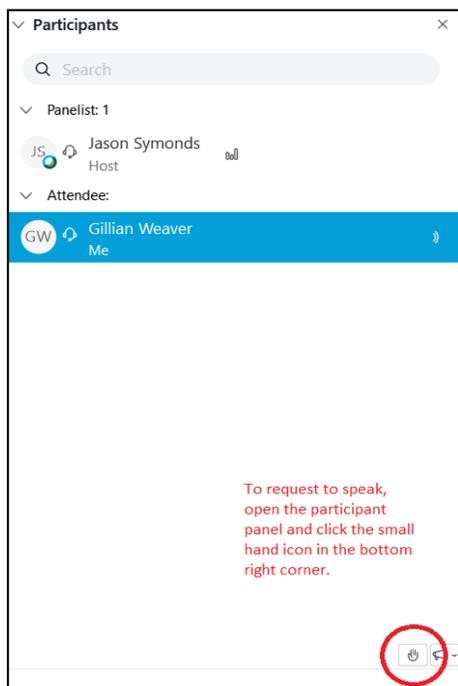
Opportunities for Comment

The Low Income Oversight Board (LIOB) will accept oral comments on each agenda item during the meeting, as well as general comments at the start of the meeting. Members of the public or community based organizations are encouraged to provide comment to the Low Income Oversight Board during Agenda Item 4 or if requested by the Board.

Agenda Item 4: Public Comment

Public comment is intended to provide an opportunity for members of the public who wish to address the board on a topic that is not on the agenda. Members of the board are not allowed to take any formal action on an item not on the agenda. If possible, it is requested that public comment be limited to 2 minutes per speaker.

To comment in **English**, please use the “Raise Hand” feature of Webex:



1. Open the Participant Panel and locate your name under Attendee.
2. Identify the hand icon in the lower right corner. This is the Raise Hand Button.
3. Click on the Raise Hand button which will place a small hand icon next to your name in the participant list.
4. When the Host calls your name to invite you to speak and unmutes you, provide comment.
5. After speaking, click on the Raise Hand icon again to put your hand down.
6. If the Raise Hand feature does not work, please use the Chat box to message the Host and request to speak.

To comment in **Spanish**, please request to comment when indicated by the phone operator:

1. During agenda item 4, the operator of the Spanish phone line will ask listeners if they have public comment.
2. Follow the instructions from the operator and provide your comment when indicated to do so.
3. This comment will then be translated to English to other participants of the Webex Event.
